Abstract

Abstract

A clustered randomized trial in Bangladeah examines alternative strategies to reduce child marriage and toenage childbearing and increase girls' admostion. Communities were randomized into three treatment and one mutual group in a 2.11.27 ratio. From 2008, girls in treatment communities received either i) a six-nonth empowement program, a) a financial incentive to delay marriage, or iii) empowement plus incentive. Data from 19,000 girls 4.5 years after program completion show that girls eligible for the incentive for at least two years were 22% (~9.5ppts, p<0.01) [loss likely to be married under 18, 14% (~5.5ppts, p<0.01) [loss likely to have given birth under 20, and 22% (5.5ppts, p<0.05) more likely to be in school at age 22. Unlike other incentive programs that are econditional on girls staying in school, an incentive conditional on marriage alone has the potential to benefit cut-of-or-hood girls. We find insignificantly different effects for girls in and out of school at baseline. The empowement program did not decrease shild marriage or tensage childbearing. However, girls eligible for the empowement program were 12% (3.1ppts, p<0.005) more likely to be in-school and had completed 2.9 mourhs (0.24 years, p<0.10) of additional schooling.
